Dear Parents and Carers of the Kimberley School

The guidance on <u>maintaining educational provision</u> was published last night and it establishes some key principles that will help us plan for next week and beyond.

- If it is at all possible for children to be at home, then they should be.
- the most recent scientific advice on how to further limit the spread of COVID-19 is clear. If children can stay safely at home, they should, to limit the chance of the virus spreading.
- Parents should not rely for childcare upon those who are advised to be in the stringent social distancing category such as grandparents (aged 70+), friends, or family members with underlying conditions
- Parents should also do everything they can to ensure children are not mixing socially in a way which can
 continue to spread the virus. They should observe the same <u>social distancing principles</u> as adults
- the government has asked parents to keep their children at home, wherever possible, and asked schools to remain open only for those children who absolutely need to attend
- the fewer children making the journey to school, and the fewer children in educational settings, the lower the risk that the virus can spread and infect vulnerable individuals in wider society

Schools are, therefore, being asked to continue to provide care for a limited number of children - children who are vulnerable and children whose parents are critical to the Covid-19 response and cannot be safely cared for at home. This provision is there for when it is essential. Please do not use it if it is just convenient, please do not use it just because you think your child will work better at school than at home.

Vulnerable Children

The government defines vulnerable children as those who are supported by social care, those with safeguarding and welfare needs, including child in need plans, on child protection plans, 'looked after' children, young carers, disabled children and those with an EHCP. We have contacted these parents directly already.

Children whose parents are critical to the Covid-19 response and cannot be safely cared for at home

The governments' definition of sectors where employment could be crucial to the Covid-19 response is set out on the next page. You will need to have confirmed with your employer that your job is critical to the Covid-19 response and you are not able to safely care for your child at home

I am a critical worker or have a vulnerable child but I don't want to send my child in to school or childcare, do I have to?

You do not have to send them. The government guidance sets out "Many parents working in these critical sectors may be able to ensure their child is kept at home. Every child who can be safely cared for at home should be. This is an offer to parents and carers and there is no requirement for parents and carers to send their children to school if they do not need or wish to do so. For vulnerable children, your child's social worker will work with you to assess the best option for your child."

Employment Categories

The guidance sets out that "If workers think they fall within the critical categories then they should confirm with their employer that, based on their business continuity arrangements, their specific role is necessary for the continuation of this essential public service."

Health and social care

This includes but is not limited to doctors, nurses, midwives, paramedics, social workers, care workers, and other frontline health and social care staff including volunteers; the support and specialist staff required to maintain the UK's health and social care sector; those working as part of the health and social care supply chain, including producers and distributers of medicines and medical and personal protective equipment.

Education and childcare

This includes nursery and teaching staff, social workers and those specialist education professionals who must remain active during the COVID-19 response to deliver this approach.

Key public services

This includes those essential to the running of the justice system, religious staff, charities and workers delivering key frontline services, those responsible for the management of the deceased, and journalists and broadcasters who are providing public service broadcasting.

Local and national government

This only includes those administrative occupations essential to the effective delivery of the COVID-19 response or delivering essential public services such as the payment of benefits, including in government agencies and arm's length bodies.

Food and other necessary goods

This includes those involved in food production, processing, distribution, sale and delivery as well as those essential to the provision of other key goods (for example hygienic and veterinary medicines).

Public safety and national security

This includes police and support staff, Ministry of Defence civilians, contractor and armed forces personnel (those critical to the delivery of key defence and national security outputs and essential to the response to the COVID-19 pandemic), fire and rescue service employees (including support staff), National Crime Agency staff, those maintaining border security, prison and probation staff and other national security roles, including those overseas.

Transport

This includes those who will keep the air, water, road and rail passenger and freight transport modes operating during the COVID-19 response, including those working on transport systems through which supply chains pass.

Utilities, communication and financial services

This includes staff needed for essential financial services provision (including but not limited to workers in banks, building societies and financial market infrastructure), the oil, gas, electricity and water sectors (including sewerage), information technology and data infrastructure sector and primary industry supplies to continue during the COVID-19 response, as well as key staff working in the civil nuclear, chemicals, telecommunications (including but not limited to network operations, field engineering, call centre staff, IT and data infrastructure, 999 and 111 critical services), postal services and delivery, payments providers and waste disposal sectors.
